Overview

The Health Service System provides medical benefits to the employees and retirees of four major San Francisco public-sector employers – the City and County of San Francisco, the San Francisco Unified School District, the San Francisco Community College District and the San Francisco Superior Court. The following pages contain a snapshot of our membership demographics as of July 1, 2008. Since our last report of July 1, 2007, the System has seen an increase of 578 in total covered lives under our medical plans. This reflects a slight reduction in active lives covered (-99) and a small increase in retired lives covered (+677).

In general, the statistics regarding plan participation remained stable with no significant migration between plans.

In addition, the System provides dental benefits to active employees of the City and County of San Francisco and to all retired members and their dependents. Since our last report of July 1, 2007, the System has seen an increase of 1,898 in total covered lives under our dental plans.

Finally, this report also surveys medical plan participation by county and offers an overview of Flexible Spending Account (FSA) participation.

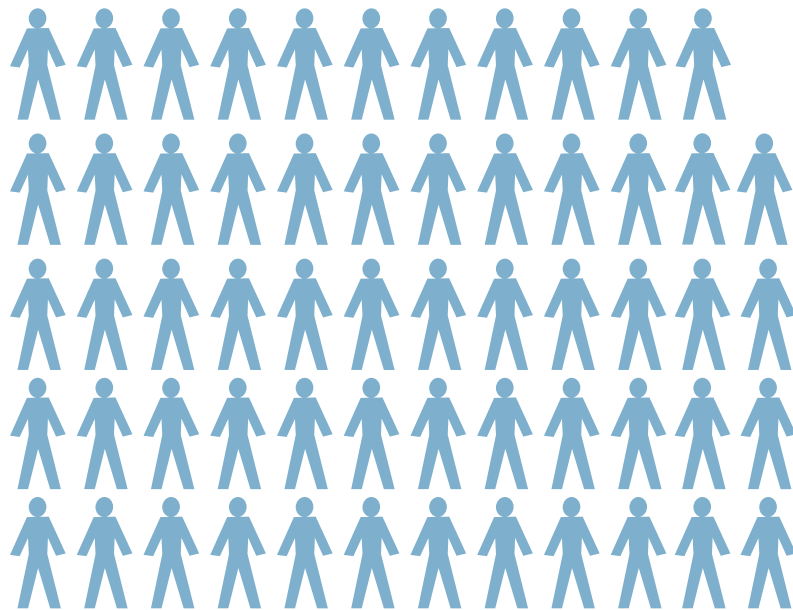

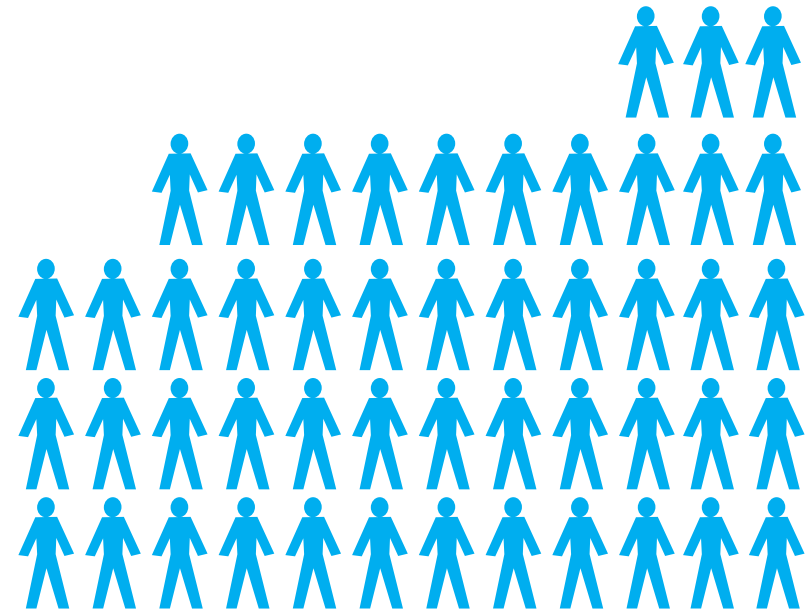

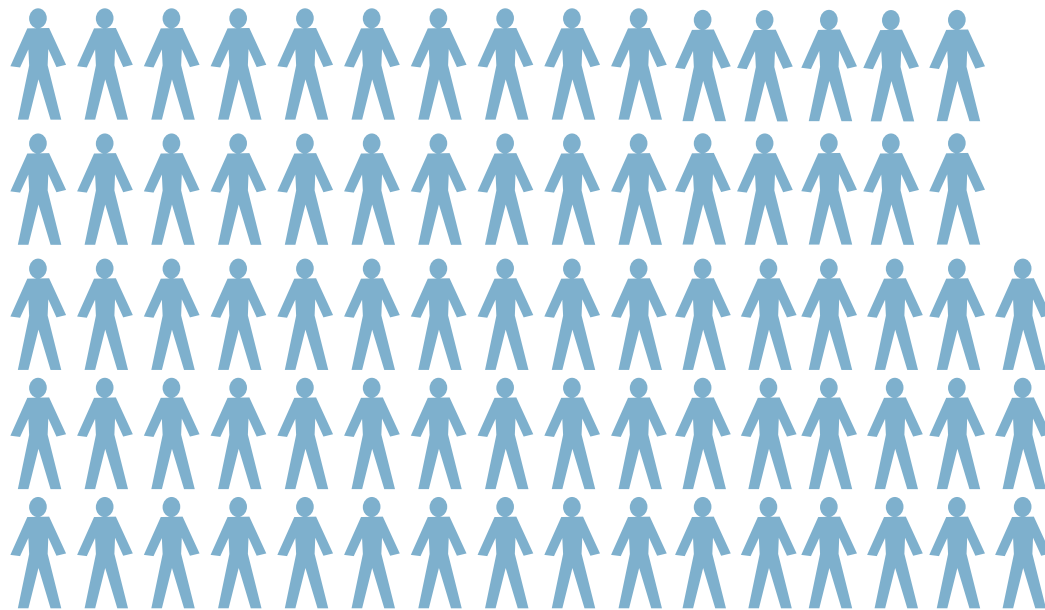

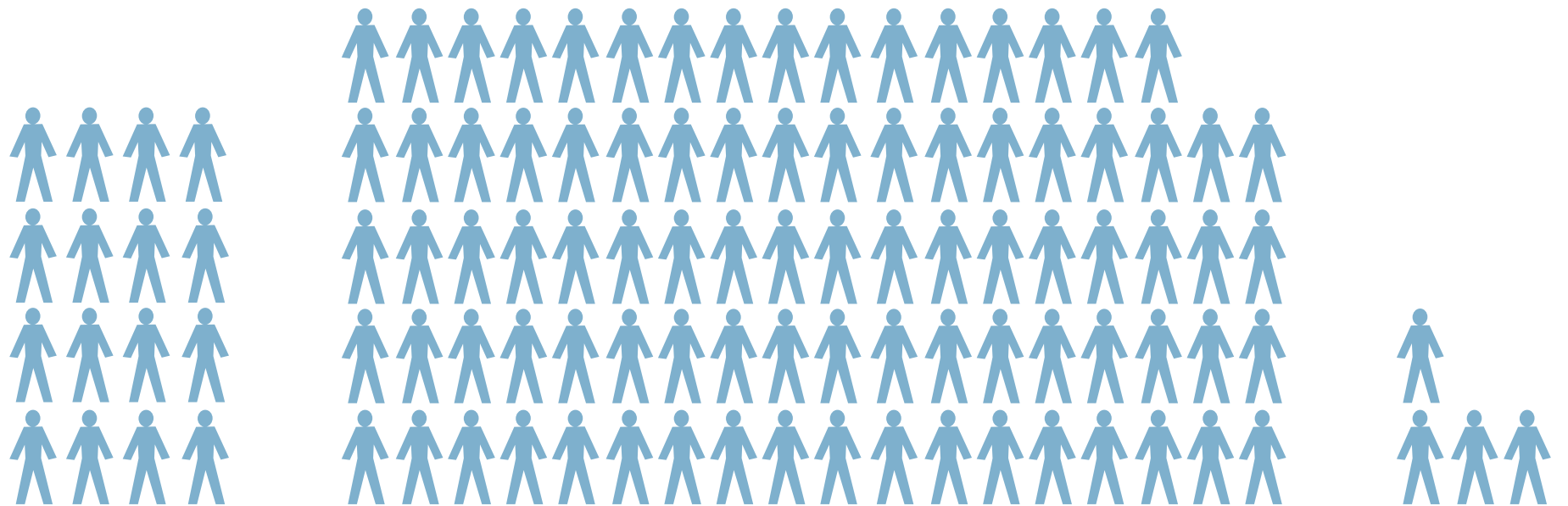

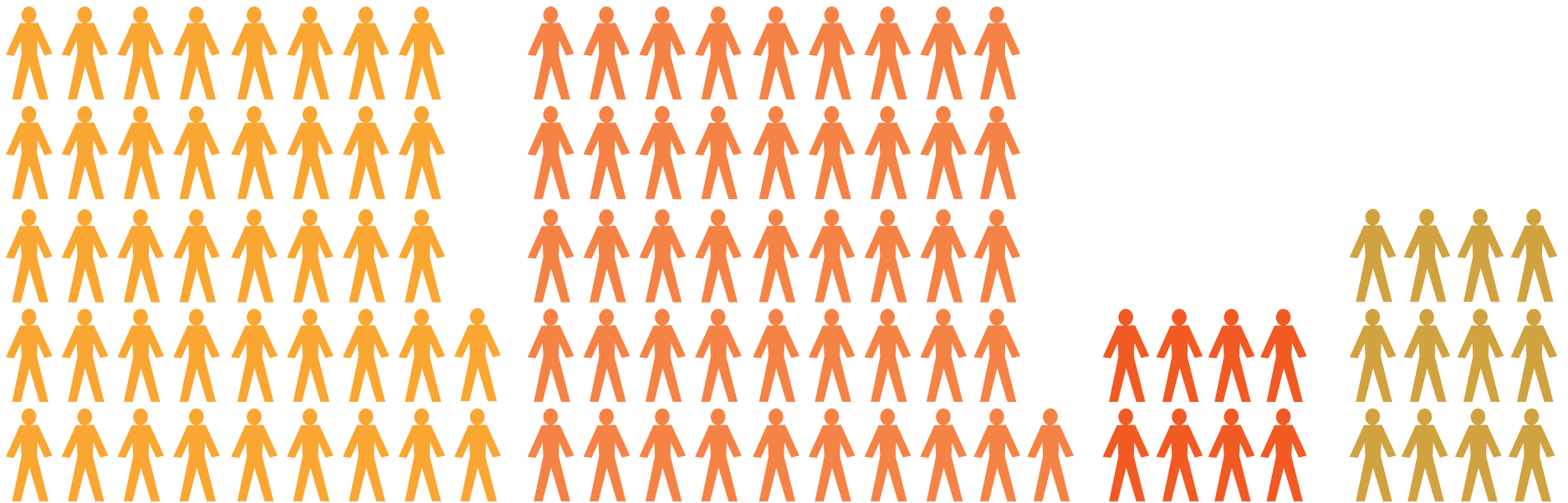

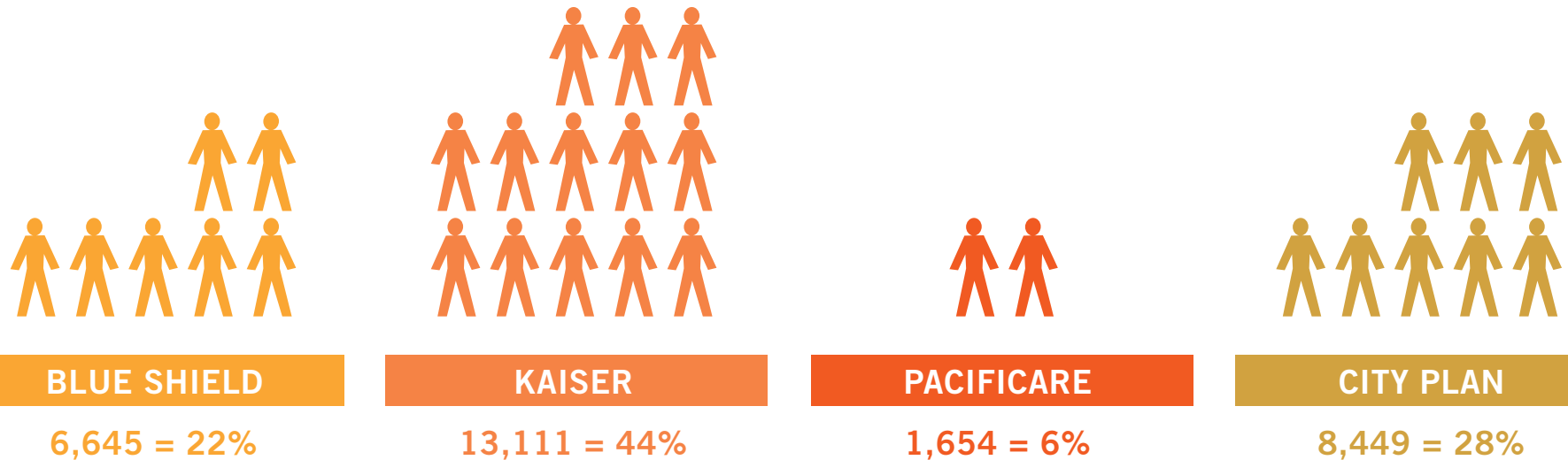

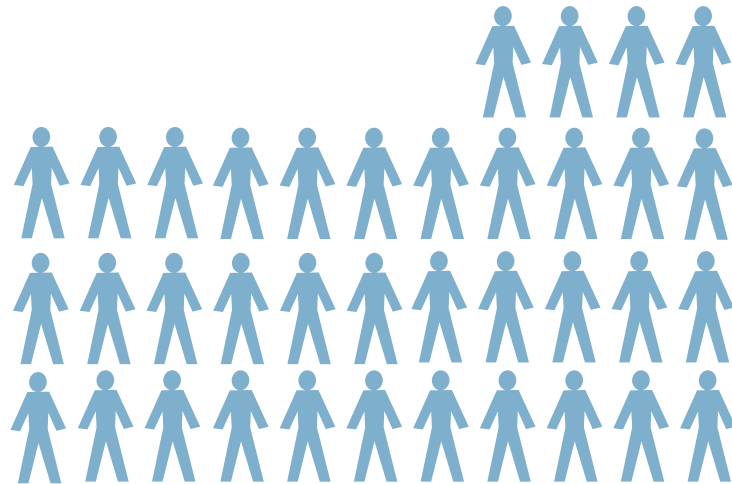
MEDICAL PLAN ENROLLMENT: RETIRED LIVES BY PLAN

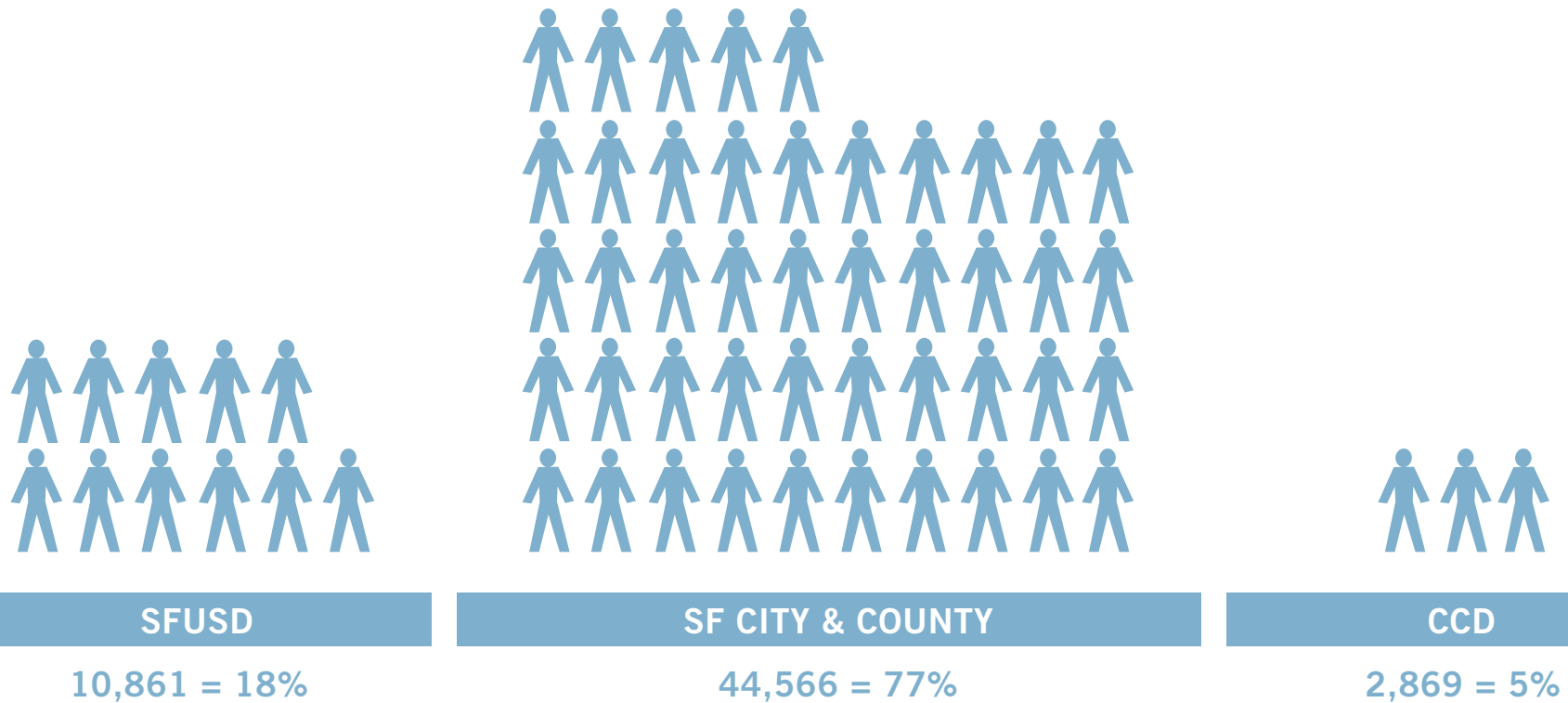

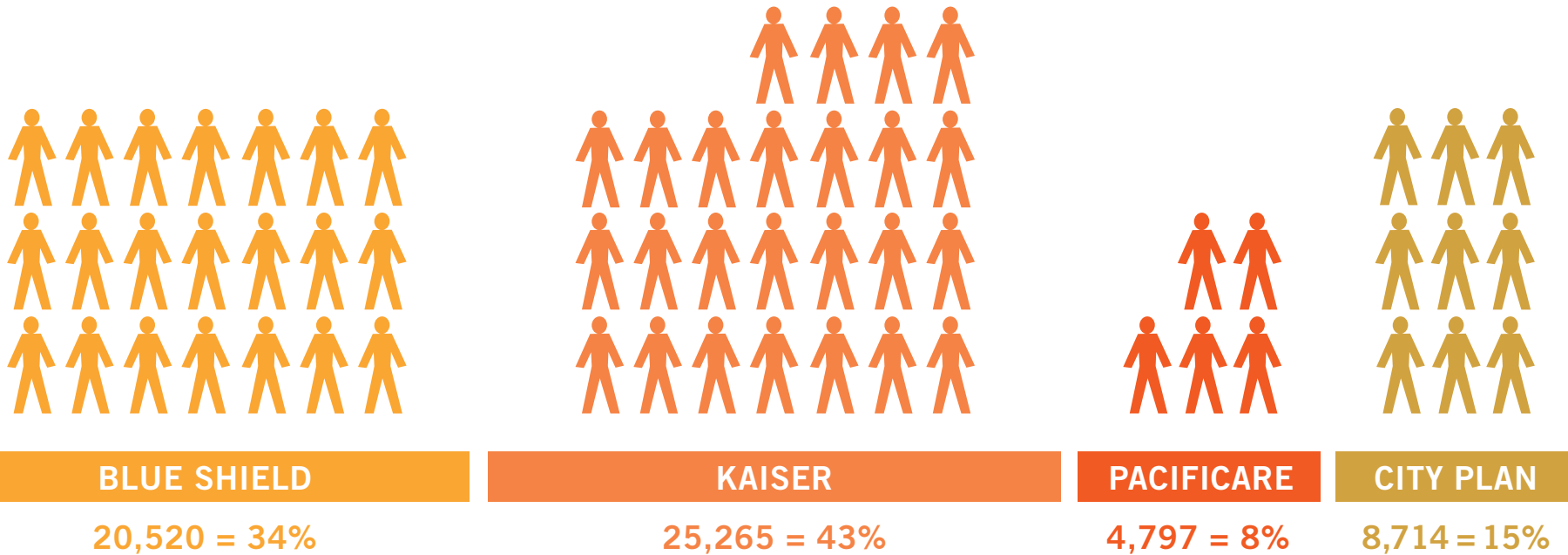

MEDICAL PLAN ENROLLMENT: TOTAL MEMBERS BY EMPLOYER



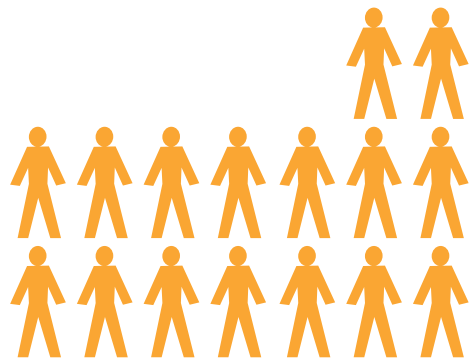

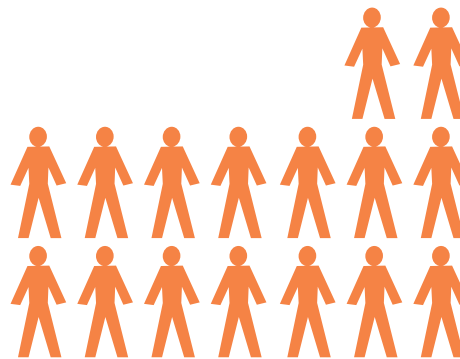

MEDICAL ENROLLMENT: ACTIVE MEMBERS BY PLAN



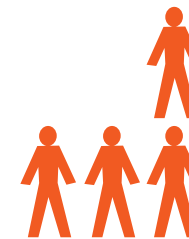

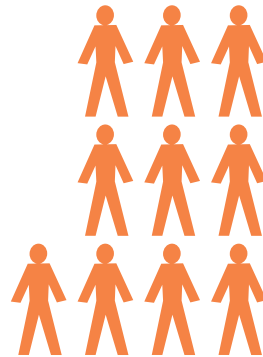

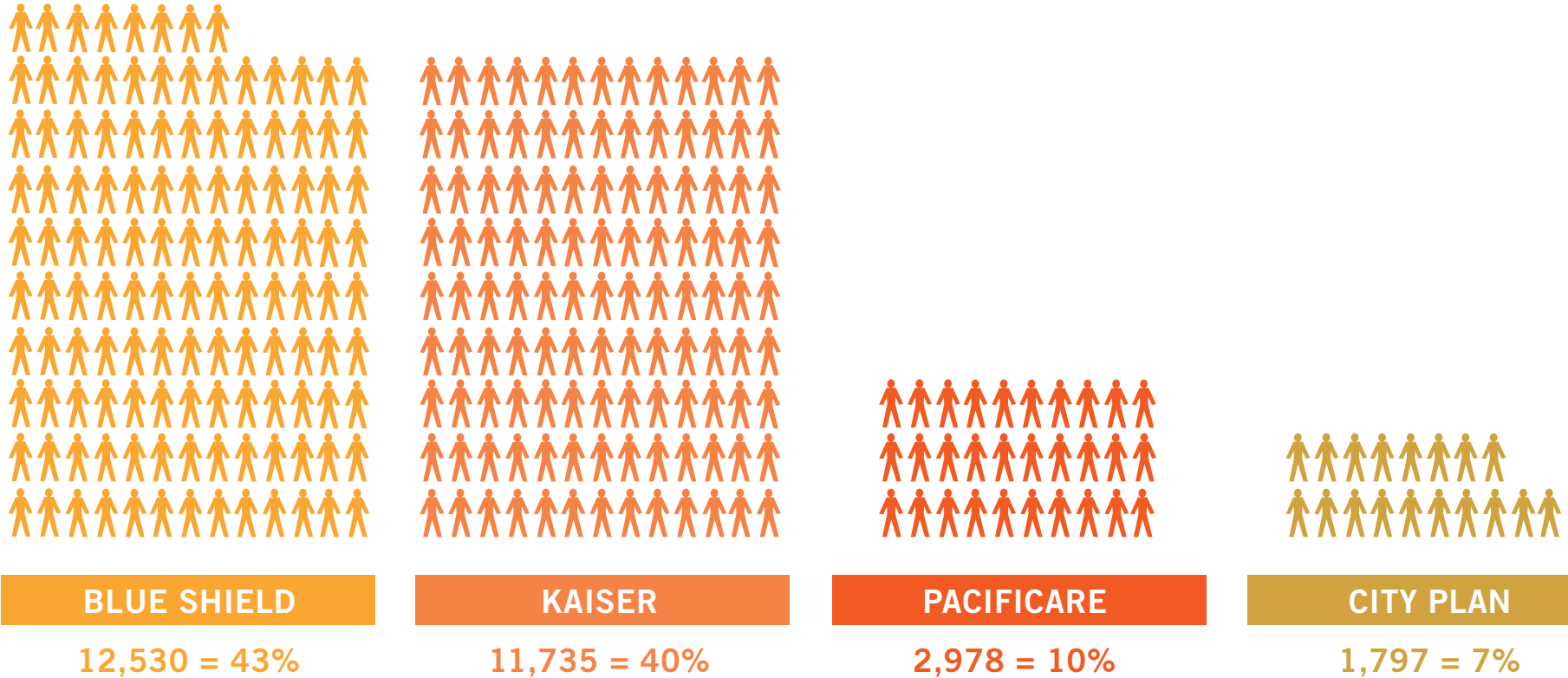

MEDICAL PLAN ENROLLMENT: BREAKDOWN BY EMPLOYER

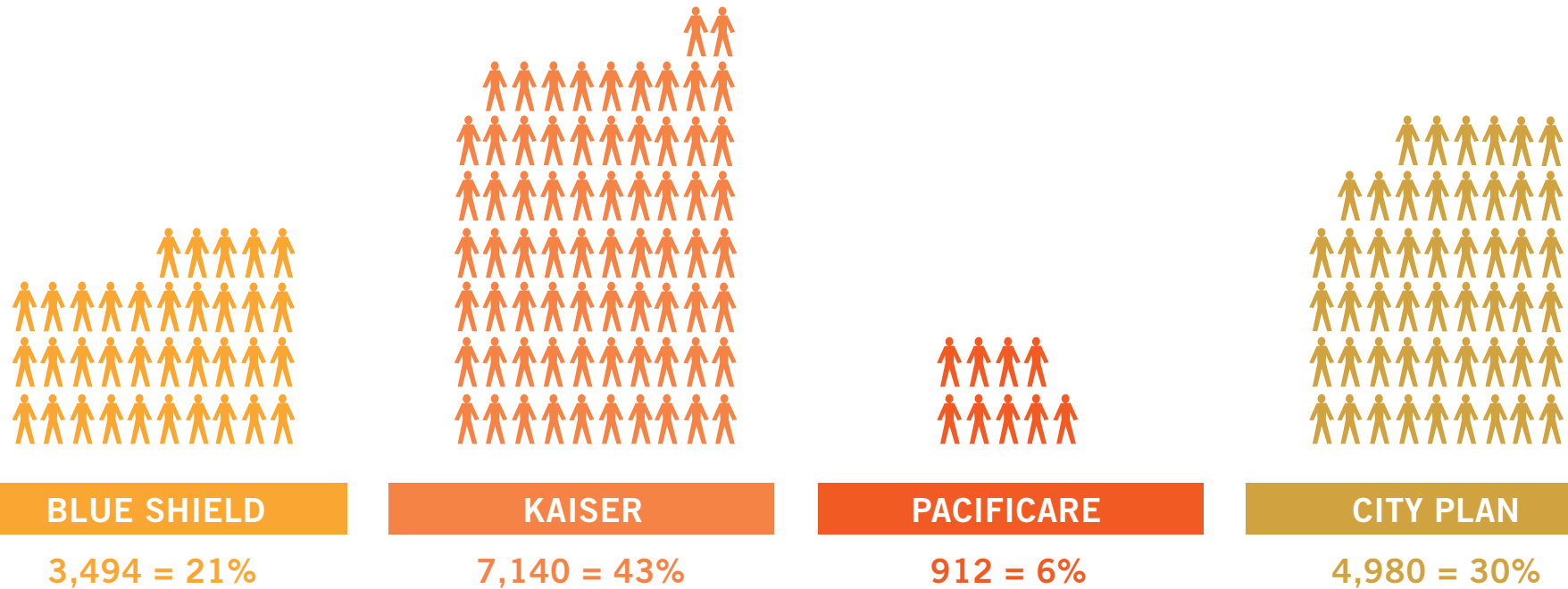
MEDICAL ENROLLMENT: ACTIVE CCSF MEMBERS BY PLAN

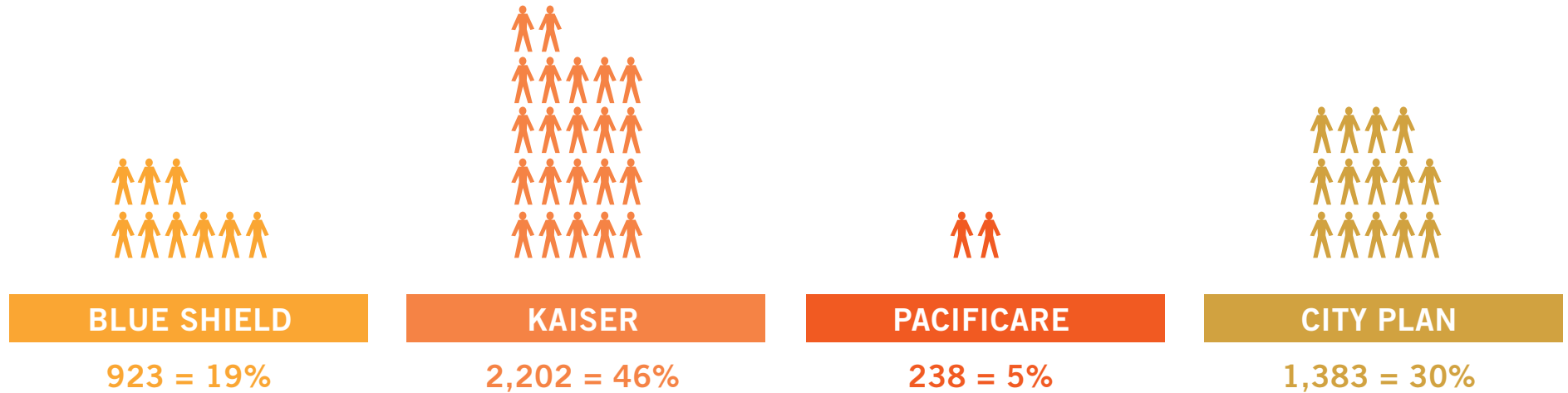

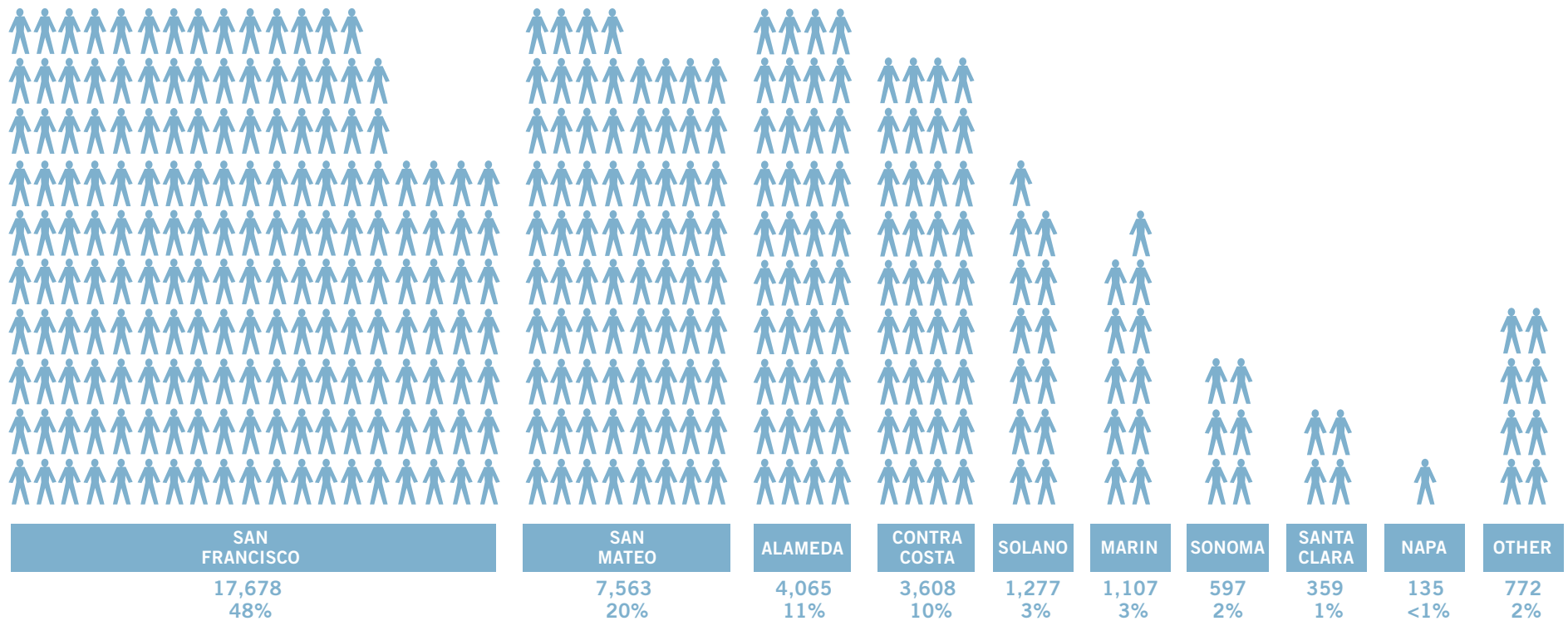
MEDICAL ENROLLMENT: RETIRED CCD MEMBERS BY PLAN

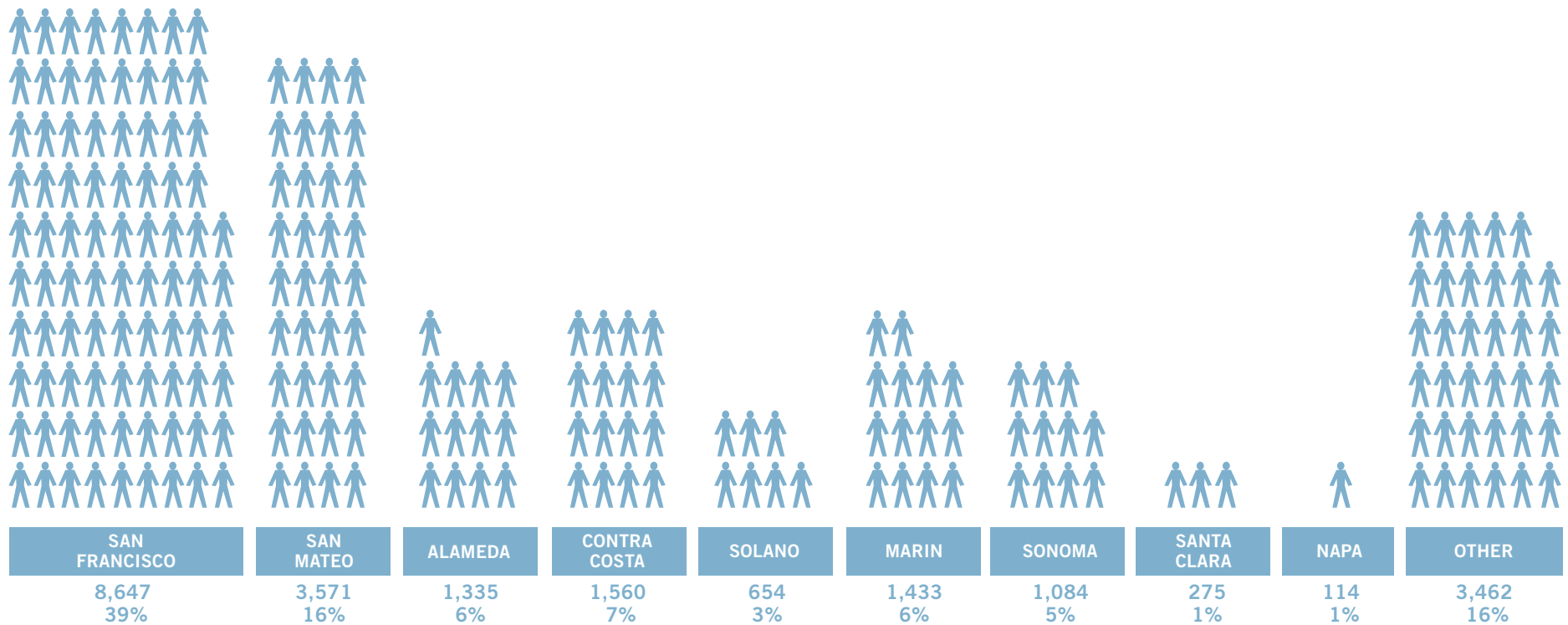
MEDICAL PLAN ENROLLMENT: BY COUNTY

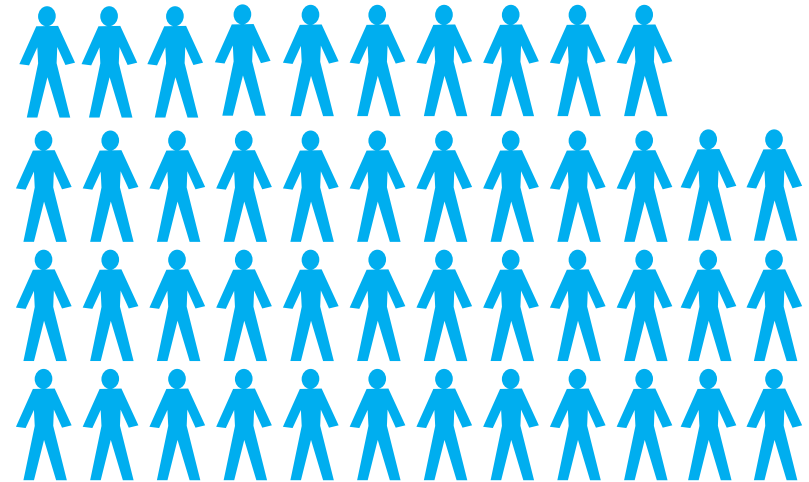

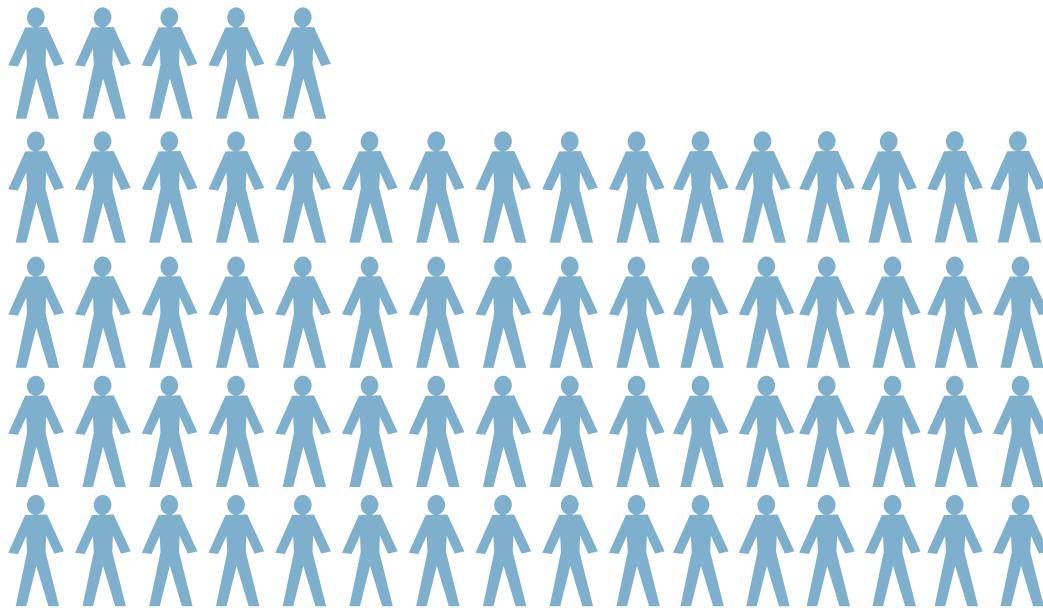

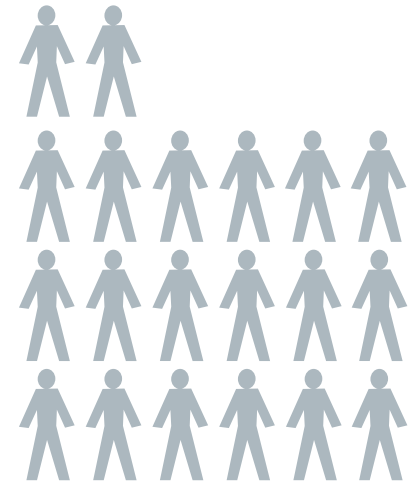

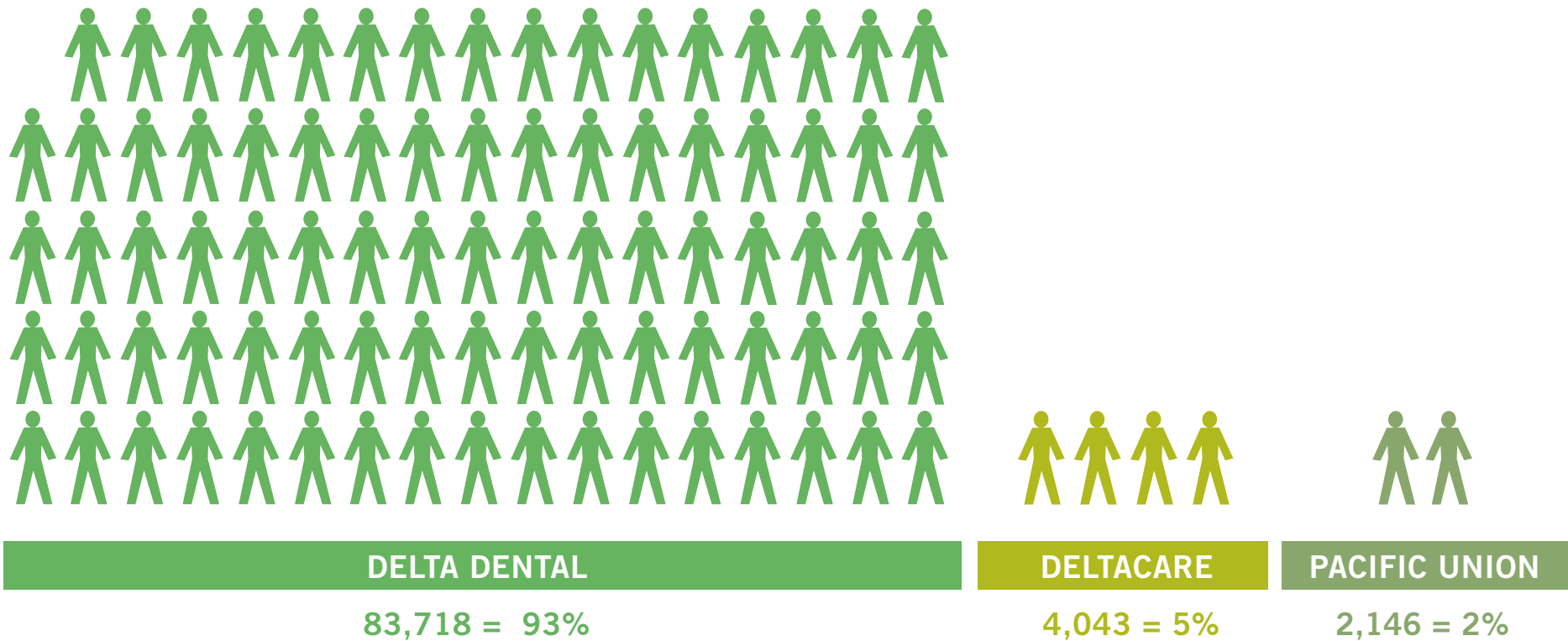

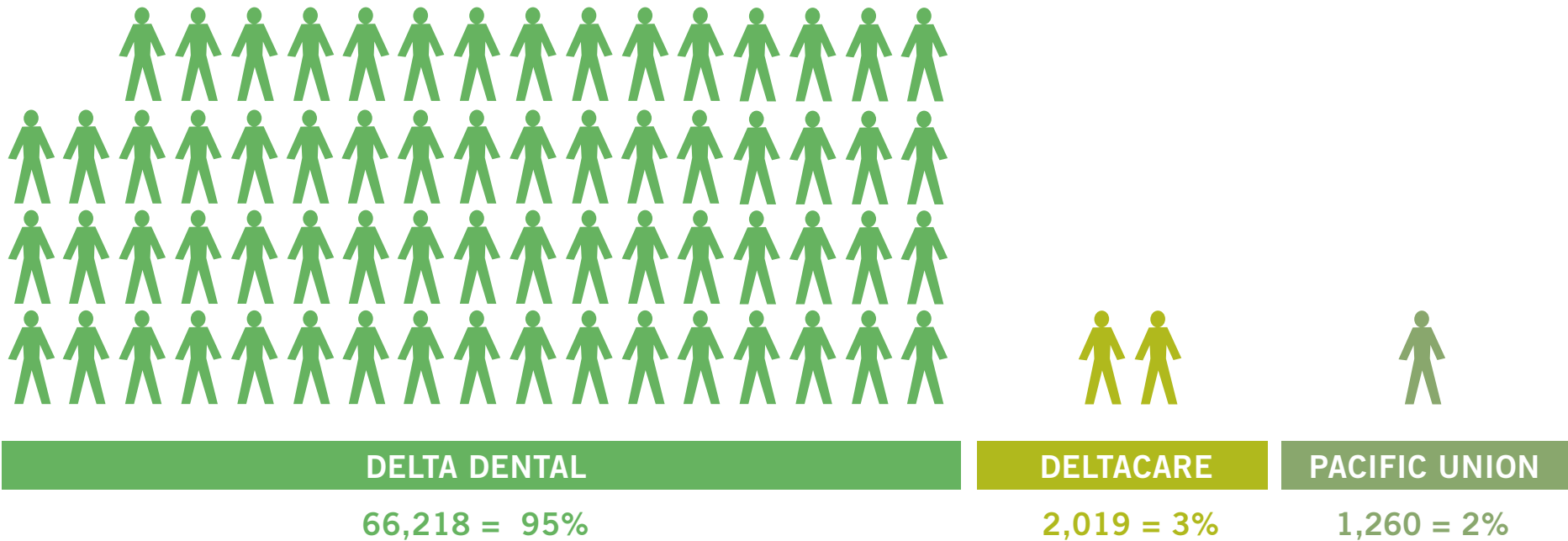
TOTAL DENTAL LIVES = 89,907

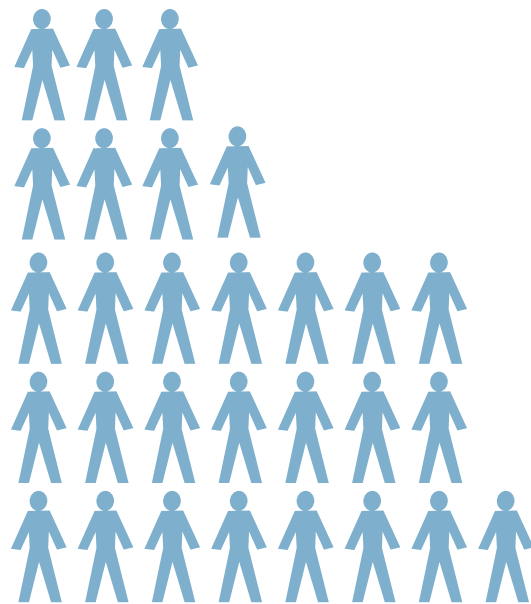

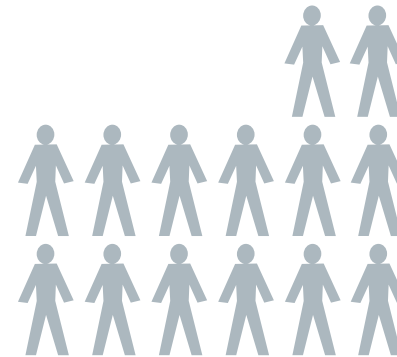

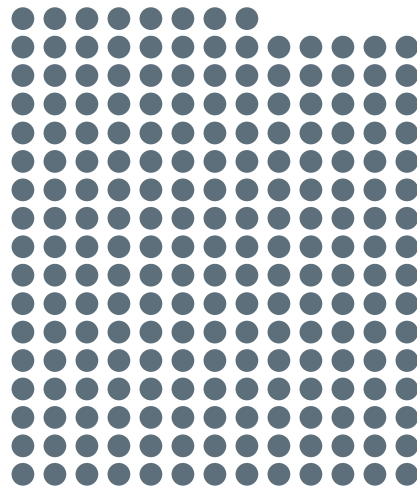

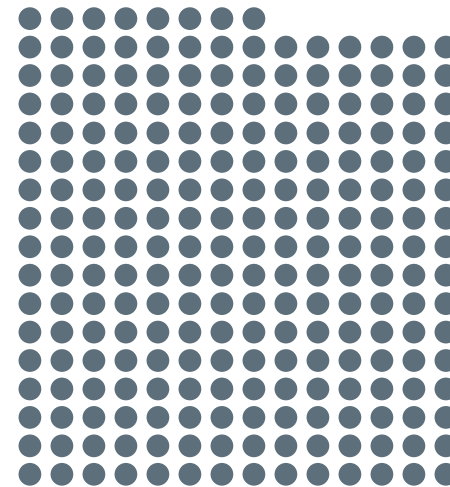

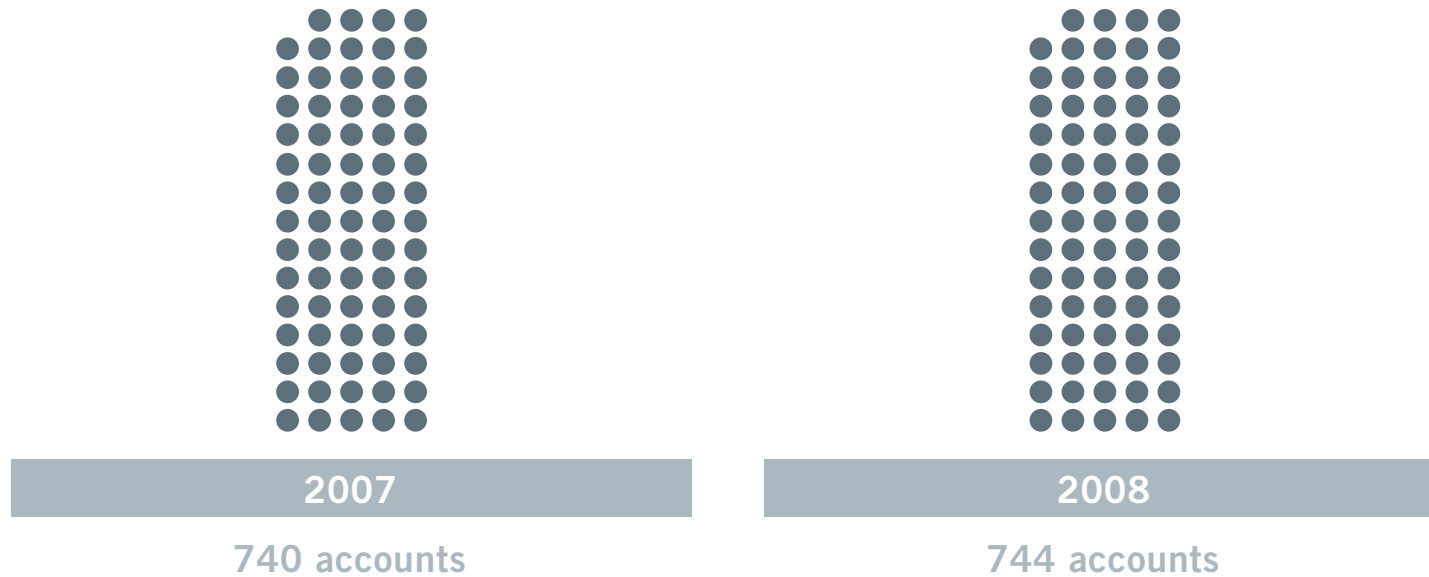
